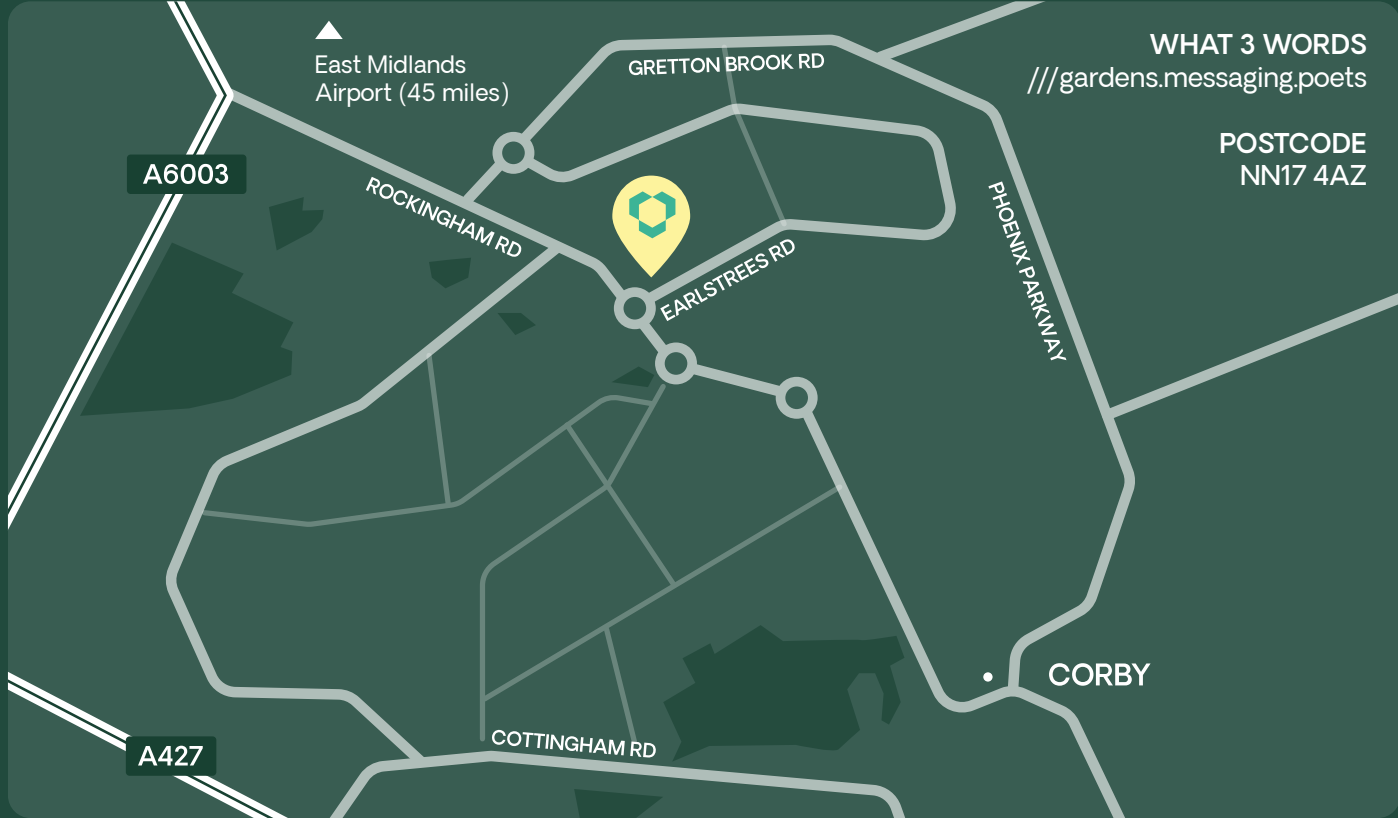
Wide Aisle Option 1
